- Detainee discussed the expulsion of Abu Sumayah the former ISI North Mosul Amir from the Si.
- Detainee provided a physical description of Abu Sumayah.
- Detainee identified Abu Rahim as the Si Amir of Jazirah.
- Detainee provided a physical description of Abu Rahim.
- Detainee identified a photograph of Rabi'ah Thamir Ahmad AKA Haydar [REDACTED] as an Si media member.

- Detainee identified Abu Qaswarah as a senior ISi Amir.

Detainee has met Tariq, AKA Abu Sumayah, the former ISi amir of North Mosul on one occasion at Haydar al-Afiri's residence. The meeting took place a month prior to Haydar al-Afiri's death [REDACTED]. There were 16 people at Haydar's residence discussing Abu Sumayah's attempt to secede from the ISi and start his own ACF group called the Dawa' al-Jihad. Abu Sumayah thought that the ISi was not living up to its own principles and were taking money from innocent people. Abu Sumayah wanted to start a group devoted to Jihad as Abu Sumayah saw Jihad. Detainee's impression of Abu Sumayah was a person who is power hungry and wanted to be the supreme leader who answered to no one. The ISi did not allow Abu Sumayah to leave the ISi. Abu Sumayah was placed under house arrest by Abu Fu'ad a military amir under the orders of Anmar the ISi Wali of Mosul. Abu Sumayah promised not to start his own group and was kicked out of the ISi then released from house arrest after one day of captivity. Abu Sumayah has expressed an interest in returning to the ISi but has not been accepted back in to the group. Detainee provided the following description of Abu Sumayah:

[REDACTED] Detainee has seen Abu Sumayah on the east side of Mosul near the stadium at Mosul University and at the Hay al-Muthanna Market.

Abu Rahim is the ISI amir of Jazirah. Abu Rahim is a turkoman from Tai Afar. Detainee believes that Abu Rahim lives in Mosul because Detainee has seen Abu Rahim in the Hay al-Sumar area on several occasions. Detainee does not have a personal relationship with Abu Rahim but will exchange greetings with Abu Rahim on the street. Detainee saw Abu Rahim at the Suq al-Ma'ash two months prior to Detainee's capture. Abu Rahim was a passenger in a white 1980s Datsun pickup truck. The truck had a metal rail around the bed and was loaded with vegetables. Detainee did not recognize the driver. Detainee provided the following description of Abu Rahim:

Abu Qaswarah is a senior ISI leader. Abu Qaswarah's position is higher than the Wali of Mosul but Detainee does not know Abu Qaswarah's exact position and responsibilities in the ISI. Detainee's knowledge of Abu Qaswarah is second hand. Detainee overheard Hamid and Faris talking about Abu Qaswarah in reference to the problem that occurred between the ISI and the Jaysh al-Muhyadin. Hamid mentioned to Firas that Abu Qaswarah had been notified regarding the situation. Detainee has never met Abu Qaswarah. The Wali of Mosul is the only person that should have contact with Abu Qaswarah.
